## BACKGROUND

South Gippsland Water is embarking on a community consultation program that will help influence and shape the future of the organisation.

Our current Water Plan finishes in June 2018. A new plan needs to be submitted to the Essential Services Commission, the economic regulator for the Victorian Water Industry.

Customer and community input will be integral to the planning process, and South Gippsland Water is seeking feedback from individuals, groups, local businesses and industry regarding matters of significance.

A Pricing Review Advisory Panel is being established to enable the Corporation to be well informed of community preferences and concerns regarding service provision and future pricing.

Panel membership will consist of between 15 to 25 representatives drawn from a broad cross section of business and the community.

The panel will meet approximately six times during over the coming 12 months to contribute to and enhance the Corporation's consultation process. Members will receive a sitting fee and travel reimbursement from home or workplace for the meetings attended.

The panel will be a significant voice in driving the Pricing Review and the membership will be provided with the opportunity to develop a thorough understanding of the Corporation and the review process.
