To ensure that the wastewater treatment plants, grounds and any associated works are operated and maintained to a high standard. To set priorities for assigned treatment plants in relation to required corrective actions, plant maintenance,

improvements and operations.

- To assist with setting priorities for assigned treatment plants in relation to required corrective actions, plant improvements and plant operations
- Ensure reasonable care is taken for own health and safety as well as the health and safety of others. Operate consistent with SGW Occupational Health and Safety policy and procedures at all times.
- At all times adhere to the Victorian Public Sector (VPS) Code of Conduct and model the South Gippsland Water Behaviours for Growth.

Qualifications

- Level 2 First Aid training
- Confined space training
- Possess a current Victorian drivers license
